- The Library building and property is owned by the Township and the general repairs and maintenance is share between the two partners. This includes some municipal services like snow clearing.
- Day to day financials are shared between Township and Library Board. The Township performs functions like bill payments and payroll. The Library Board sets budget and monitors spending.
- Interesting that Libraries fall under the Ontario Ministry of Tourism, Culture and Sport.
- Conversations around our Statistic Programs and an interest in how the data is used. Also interested in how programs are evaluated. Corrinne indicated that programs are often evaluated using a scale of five smiley faces but happy to investigate or improve this process.
- The Ministry provides a fixed grant of \$24,176.00 which is surprisingly low and unchanged for many years. The major funder for the Library's budget is the Township, through the residential tax levy. The Township is an important partner.
- OLS supports our e-resources (ie. Libby) and allows Libraries to purchase services/products at a bulk rate.
- Ontario Libraries are guided by provincial legislation (PLA) and is very different than all other provinces in Canada.
